investments in the dairy production and distribution sector. Amount in dispute exceeds US\$800 million.

- Represented an investor in an ICSID arbitration against the Bolivarian Republic of Venezuela concerning the State's temporary takeover and interference with the claimant's local paper and manufacturing enterprise, securing an award of US\$394 million.
- Represented an electricity company and its parent company in an ICSID arbitration against the Republic of Peru arising from the regulatory agency's withdrawal of an exclusive right to provide services related to the frequency of the power generation system, in a dispute valued at approximately US\$200 million.
