PROFESSIONAL PRACTICE

He has acted in arbitrations under all the major arbitral rules such as the International Centre for Settlement of Investment Disputes (ICSID), the United Nations Commission on International Trade Law (UNCITRAL), the International Chamber of Commerce (ICC), the International Centre for Dispute Resolution (ICDR) and the Madrid International Arbitration Center (CIAM) securing many landmark victories for his clients.

His recent victories include successfully representing the owner of the largest solar energy facility in Central America in an ICC arbitration against an energy distribution company due to the breach of two power purchase agreements (PPAs), as well as a Central American State and two companies of the region in the negotiation of commercial and investment disputes.

He also represented the Republic of Guatemala in the *IC Power* and *Iberdrola* cases, where all claims were dismissed, as well as his home country, Colombia, in an ICSID case initiated by *America Móvil*, dismissing claims exceeding US\$ 1 billion. He also successfully represented a Swiss pharmaceutical company in an ICDR arbitration against his distributor in 2 Latin American countries.

Juan Felipe is an adjunct lecturer of Investment Arbitration at Universidad de los Andes and Universidad del Rosario. He is also frequently invited to teach at American University and Georgetown University.
