<u>Investment arbitration (counsel)</u>

- Advised a Chinese construction company on a potential ESGrelated claim against a Central American State arising from a major transportation infrastructure contract.
- Part of the team that represented an investor in an ICSID arbitration against the Republic of Peru, arising from a concession contract, concerning delays and damages in the construction of a major railway infrastructure project.

Commercial arbitration (counsel)
